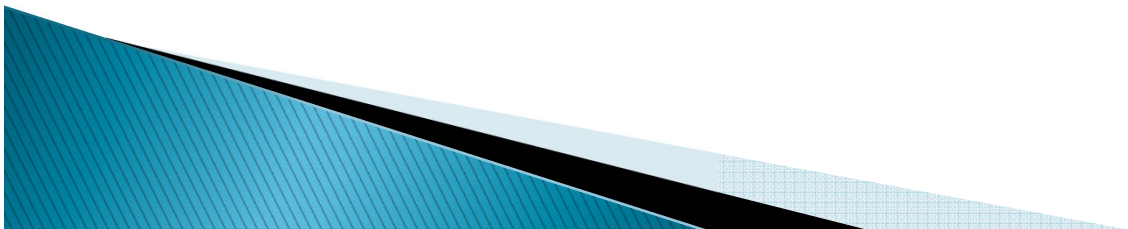

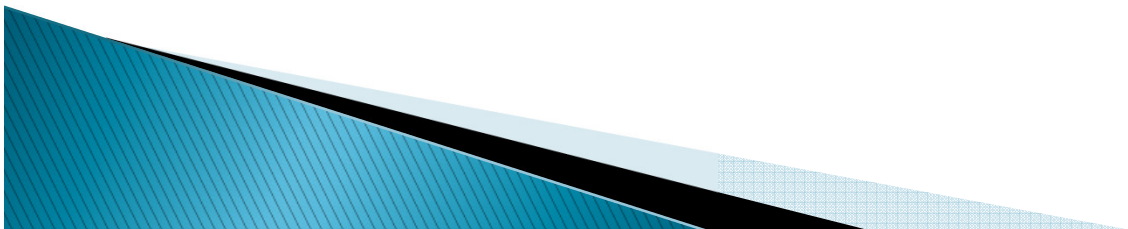
OC/NETI Training Challenges

- ▶ Declining resources and funds for training.
 - Course development
 - Staffing & eLearning expertise
 - Training rooms
 - Equipment
 - Learning Management System
- ▶ Increasing demand for inspector training
 - Inspector credentials
 - IG reports about consistency of inspector training



OC/NETI Training Solutions

- ▶ Improve online training capability
 - Develop new online courses in-house
 - Improve eLearning techniques
 - Improve use of webinars
- ▶ Improve LMS to manage SCORM elements
- ▶ Use Agency-wide software solutions
- ▶ Do more with less

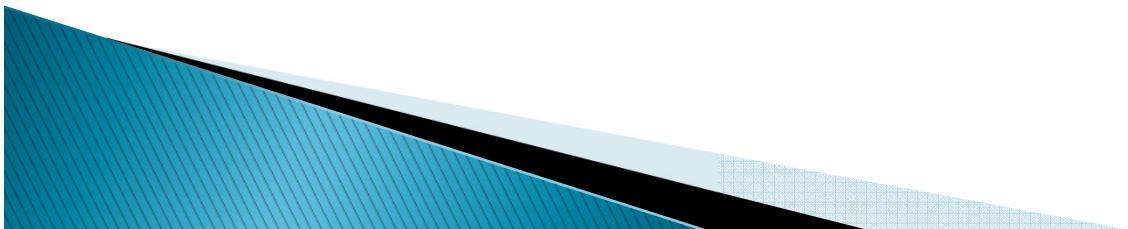


Developing the NETI eLearning Center

- ▶ NETI selected Adobe Connect to be the new Learning Management System
- ▶ NETI Web Page is the LMS landing page
 - NETI eLearning Center
 - <http://www.epa.gov/compliance/training/neti/index.html>
- ▶ The Center hosts eLearning training courses that meet current technology and eLearning standards
 - Sharable Content Object Reference Model (SCORM) and Section 508
 - The Center will track a learner's progress and results for each eLearning courses taken

Developing eLearning Expertise

- ▶ The Office of Compliance purchased:
 - Training Module in Adobe Connect -- the LMS
 - 14 licenses of the Adobe Learning Suite (Captivate, Presenter, Photoshop, etc.)
 - Distributed to staff across the 4 OC divisions.
 - 5 days (40 hours) of classroom training in the ALS software and eLearning for 20 OC staff
 - An additional 40 hours of ongoing ALS training.
 - eLearning training from ADTD and Allen Interactions for 10 OC staff

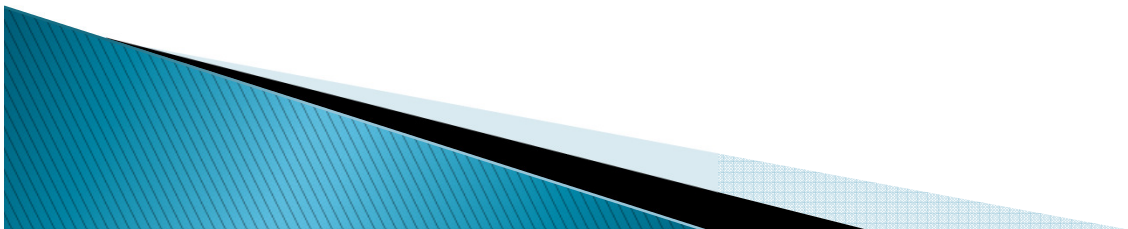


eLearning Achievements

- ▶ Prepared guidelines and standards for eLearning courses hosted on the NETI eLearning Center site
- ▶ OC staff began authoring required Environmental Inspector Credential courses in the new Adobe Captivate or Presenter software, in July 2012
- ▶ To date, 10 courses have been developed for Federal, State, Local, and Tribal environmental professionals
- ▶ Courses now on the Center website:
 - Basic Inspector Training
 - Environmental Statutes (pending)
 - NPDES Inspector Training (3 courses)
 - RCRA Inspector Training (3 courses)
 - FIFRA Inspector Training
 - PCB Inspector Training

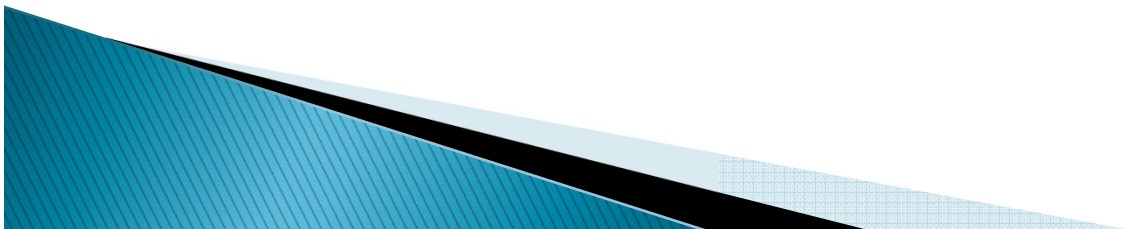
Additional Center Course Material

 - Listing of upcoming webinars



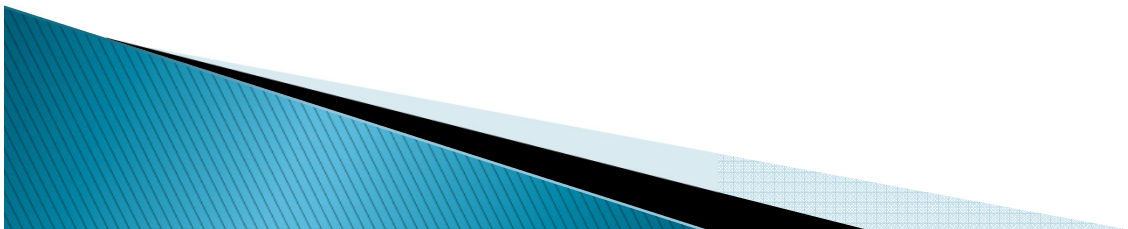
NETI eLearning Center eLearning Community

- ▶ All EPA personnel are “Registered Users”
 - Access to all Center courses with their User Name (EPA email address) and Password (generated through Adobe Connect)
- ▶ State, local, and tribal personnel have access to all Center courses
 - They need to register and be approved to take each course



Field Equipment and Technology Course

- ▶ Course title: Field Equipment and Technology
- ▶ Goal of course:
 - Help meet the requirements of the FOG guidelines for standardizing field operations
 - Serve as a Basic Inspector Training “Refresher Course” per the new EPA Order 3500.1
- ▶ Equipment covered in initial course
 - Infrared Camera (FLIR)
 - Photoionization Device (PID)
 - ISCO Water Sampler
