Additional questions from approximately August 2018 (responses from the leads)

(1) Question: Is vehicle leasing allowed, or must all vehicle replacements be purchased?

Answer: The EPA FAQs and the AG's Group Q&As do not address this question. The AG's Group Q&A from June of 2017 does include the following that may be instructive:

Question: Can the funding be used to set up tax incentive revolving loan fund or fleet voucher programs managed by an authority?

Answer: Funding requests may only be used for projects listed in Appendix D2. The mechanism of how an agency proposed to implement that project is arguably within that agency's discretion, as long as it complies with the law.

With the exception of Category 9, Light Duty ZEV Infrastructure, the word "purchase" or "purchased" does not appear in the list of Eligible Mitigation Actions set forth in Appendix D-2 of the State Trust Agreement. (ZEV infrastructure must be "purchased.") The word "purchased" does, however, appear in the definition of Government – "Government shall mean a State or local government agency (including a school district, municipality, city, county, special district, transit district, joint powers authority, or port authority, owning fleets purchased with government funds), and a tribal government or native village." The word "purchase" appears in the Sample Attachment B – Project Management Plan / Project Schedule and Milestones – "Project Sponsor Enters into Contracts, Purchase Orders, etc. – Start; Project Sponsor Enters into Contracts, etc. – Complete."

(2) Question: Can EMT funds be used as match for federal programs other than DERA?

Answer: Yes. Although the only federal program addressed by the State Trust Agreement is DERA, there is no language in the State Trust Agreement that would prohibit the use of VW EMT Funds as match for other programs. It is recommended that you check with your project officer and/or the federal agency that runs the program to ensure that VW EMT funds will be accepted or counted as match. Please note that if VW EMT funds are combined with any other state or federal funding, applicable state and/or federal rules, regulations, and/or program requirements may apply to all of the funds.

The EPA FAQs do not address this question. The AG's Group Q&A from June of 2017 does include the following that may be instructive:

Question: Can EMT funds be used as matching funds for grant programs other than DERA (e.g., DOE, DOT)?

Answer: Good question – if the underlying project (or aggregated sets of a particular project) is on the D2 list, EMT funds can be used. It may require creative project structuring, however.

(3) Question: Can ownership of the vehicle and the related charging infrastructure be split between two different entities?

Answer: The EPA FAQs and the AG's Group Q&A from 2017 do not address this question. The State Trust Agreement does not contain any language that would prohibit such; however, it is recommended that any state considering this will consult with their counsel. A note of caution – this could be tricky if the owner of the vehicle and the owner of the "charging infrastructure associated with" the new All-Electric engine or All-Electric vehicle are not the same type of entity (i.e., both Government or both Non-Government) and different funding caps apply to each entity type. Which funding cap controls? It is recommended that any solicitations include scenarios to address how this will be handled.
