Petitioner ARIPPA respectfully submits this response to Respondent United States Environmental Protection Agency's ("EPA") Motion To Govern Future Proceedings (Doc. 1500830). ARIPPA joined Industry/Labor Petitioners' Motion To Govern Proceedings on Remand from the U.S. Supreme Court (Doc. 1500963), and restates its support of that motion herein. ARIPPA also supports the motion to govern filed by State and Local Petitioners (Doc. 1500966). ARIPPA further supports the Luminant Petitioners' response (Doc. 1501970), and State and Local Petitioners' response (Doc. 1503207), in opposition to EPA's Motion To Govern Future Proceedings.
