MINUTES

NACAA BUSINESS MEETING

Tuesday, April 28, 2015

Tad Aburn (Maryland) and Merlyn Hough (Springfield, OR), Co-Presidents of NACAA, called the Business Meeting to order.

Approval of Minutes

The 2014 Fall Membership Meeting minutes were approved unanimously by the State Agency Members. The Local Agency Members also approved the minutes with three abstentions.

NACAA Treasury Report

Bill Becker, Executive Director of NACAA, reported on the association's finances, including both federal and non-federal funds. Bill noted that the association is in good financial shape, in part due to some carryover of funds from the first year of NACAA's two-year grant. Those funds will be used to help address the shortfall NACAA anticipates this year; NACAA will continue to seek outside funding if it is anticipated that future funding will fall short of what is needed to operate the association.

Other Business

Susan Wierman (MARAMA) announced that the Air and Waste Management Association would hold its 108th Annual Conference, "Environmental Quality to Climate:

Connecting the Dots," June 22-25, 2015, in Raleigh, North Carolina. She added that there are still opportunities available for state and local air directors to register as conference monitors to offset the cost of their participation. Bill Becker also noted that David Shaw (New York) would be honored with the S. Smith Griswold Outstanding Air Pollution Control Official Award during A&WMA's Annual Honors and Awards Ceremony on Wednesday, June 24, 2015.

Merlyn Hough advised members of the Excellence in Environmental and Engineering Science Awards which are given out each April and encouraged them to consider nominees in the field of air quality.

Finally, Bill Becker noted that Colorado Department of Public Health and Environment had received the 2015 EPA Clean Excellence Award for Regulatory/Policy Innovations for the Department's oil and gas emission reduction initiative.
