

NATIONAL ASSOCIATION OF CLEAN AIR AGENCIES 2009 SPRING MEMBERSHIP MEETING May 3-6, 2009

The National Association of Clean Air Agencies (NACAA) held its 2009 Spring Membership Meeting from May 3 to May 6, 2009 at the Westin New Orleans Canal Place in New Orleans, Louisiana. MINUTES NACAA BUSINESS MEETING Tuesday, May 5, 2009

Colleen Cripps (NV) and Arturo Blanco (Houston, TX), Co-Presidents of NACAA, called the Business Meeting to order.

Approval of Minutes

The 2008 Fall Membership Meeting minutes were unanimously approved by the membership.

NACAA Co-Treasurers' Report

Bill Becker, Executive Director of NACAA, reported on the association's finances, including both federal and non-federal funds.

Allocation of Additional FY 2009 Grants

Bruce Andersen (Kansas City, KS), Co-Chair of the NACAA Program Funding Committee, summarized the discussions the Board and Committee Chairs had at their meeting on Sunday, May 3, 2009 regarding the allocation of the small increase in FY 2009 Section 105 grants that Congress provided to state and local air agencies. The Board Members and Committee Chairs, who constitute the NACAA Program Funding Committee, had decided to recommend to EPA that the agency allocate the portion of the increase targeted to the regions for distribution to state and local air agencies as follows: one-half in the same proportion as previous direct grants have been allocated and the other half in accordance with the updated methodology for allocating grant funds that EPA has developed and shared with NACAA, using the best data EPA has at this time as inputs for the new formula. The Program Funding Committee also noted that the recommendation should not be construed as an endorsement of the new formula and revised allocation.

With respect to funding for lead monitoring in FY 2009, Bruce reported that the Program Funding Committee decided to recommend that the grants be provided under Section 103 authority because Section 103 is designed to fund, among other things, the establishment of monitoring networks. Additionally, Section 103 does not require state or local agencies to provide matching funds, which would pose a problem for many agencies.

Bruce reported that the Program Funding Committee will recommend to EPA that the agency provide continuing federal funding for the Regional Planning Organizations.

Bruce noted that the Environmental Council of the States (ECOS) would soon be meeting with EPA to recommend funding levels for each of the media programs and, accordingly, had asked NACAA for its recommendation for increases to Sections 103 and 105 grants in FY 2011. ECOS was aware of the NACAA Spring Board/Committee Chairs and Membership Meetings and was awaiting the association's recommendation following the meetings. Bruce indicated that the Program Funding Committee would recommend an increase of \$100 million over FY 2010 levels.

In response to a question about whether NACAA is consistent with ECOS in the budget discussions, Bill Becker reiterated that ECOS had asked for recommendations from NACAA and the other media associations. ECOS had indicated that it would take those recommendations and transmit them to EPA during an upcoming budget meeting. NACAA and ECOS are working closely on the budget issues.

Other Business

Bill Becker announced that John Paul (Dayton, OH) would be awarded the Air and Waste Management Association's (AWMA's) Smith-Griswold award during AWMA's upcoming annual meeting in June.

Bill provided updates about Congressional activities related to the Waxman-Markey climate change legislation. He reported that NACAA headquarters would continue to provide the members with updates about the progress of the bill.

The NACAA Business Meeting was adjourned.

The NACAA Board of Directors convened its meeting at 8:30 a.m. Those present included Bruce Andersen (Kansas City, KS), Arturo Blanco* (Houston, TX), Colleen Cripps* (NV), Joyce Epps* (PA), Larry Greene* (Sacramento, CA), Vince Hellwig* (MI) Cheryl Heying* (UT), Bob Hodanbosi (OH), Jim Hodina* (Cedar Rapids, IA), Merlyn Hough* (Springfield, OR), Jim Kavanaugh* (MO), Cindy Kemper* (Johnson County, KS), Lynne Liddington* (Knoxville, TN), John Lyons* (KY), Dennis McLerran (Seattle, WA), Bill O'Sullivan* (NJ), John Paul (Dayton, OH), Nancy Seidman (MA), David Shaw (NY), Richard Steadman (Monterey, CA), Mary Uhl* (NM), Dick Valentinetti (VT) and Michael Vince (LA). Allocation of Additional FY 2009 Federal Grant Funds

Bruce Andersen (Kansas City, KS), Co-Chair of the Program Funding Committee, presented three issues for the Committee (comprised of the NACAA Board of Directors and Committee Chairs) to decide: 1) how to allocate the additional \$2.6 million for Fiscal Year (FY) 2009; 2) whether the \$2.5 million earmarked for lead monitoring should be provided through section 103 or 105; and 3) what are NACAA's views about the Regional Planning Organizations (RPOs) not being allocated any funding under the FY2009 budget.

Bruce said EPA had presented NACAA with two options for allocating the additional \$2.6 million: 1) on a *pro rata* basis (as funding is currently distributed under Section 105) or 2) by targeting the increase so overall funding is closer to the new allocation formula. Bruce said he and Andy Ginsburg (OR), Co-Chair of the Program Funding Committee, recommended using the *pro rata* formula because the new allocation scheme has not been worked out and it was likely that the new formula would not be used until FY2011. John Lyons (KY) presented another option: use the new formula but apply it across the board, so that everyone gets some of the \$2.6 million. After discussion of this option, Andy presented another alternative: use the old formula (*pro rata*) for half of the new money and use the new formula for the other half. Several said that any communication to EPA about the funding decision should include a statement that NACAA and EPA need to discuss implementation of the new formula because there are concerns with it. People expressed concern that agreeing to use the new formula for this money might imply to EPA an endorsement of the new formula even though many believe there are problems with the formula; others expressed that since NACAA had agreed that the new formula would be applied to new money it should be applied here, since this is new money.

After lengthy further discussion, the issue came to a vote: Did the Program Funding Committee support allocating the funds on a *pro rata* basis or based on one of the compromises offered during the discussion. The Committee voted in favor of a compromise. The Committee was then asked which compromise it supported -1) applying the new formula to the \$2.6 million, with no statement about NACAA's views on the formula or 2) distributing half the funds -\$1.3 million - on a *pro rata* basis and the other half -\$1.3 million - using the new formula, with a statement expressing NACAA's concern about the new formula and that NACAA and EPA need to work on an implementation plan. By a vote of 19 to 5, the Committee approved option 2 (distributing half the funds -\$1.3 million - on a *pro rata* basis and the other half -\$1.3 million - using the new formula, with a statement expressing NACAA's concern about the new formula and that NACAA and EPA need to work on an implementation plan).

By a voice vote the Committee also voted that the lead monitoring funding should be distributed under Section 103 and not Section 105.

Regarding the RPOs, Bruce said that EPA had not allocated any money for RPO funding in FY2009 because the agency said the RPOs' work on regional haze was coming to a close and RPOs had not spent their money from last year. EPA said if the RPOs are to continue to be funded, they will need different charters and the money will have to come out of state and local air agency "pots." A couple of attendees noted that RPOs need carry over money to fund their activities and that is why they have money left over. In order to fund FY2010 activities, RPOs will need money from the FY2009 budget. Several said that the RPOs' work on regional haze was not done – states need to show a return to natural conditions by 2064. It was suggested and agreed to that NACAA send a letter to EPA supporting funding for the RPOs.

FY 2011 Budget Request for Federal Grants to State and Local Air Agencies

Bill Becker first discussed the FY 2010 budget, noting that an increase in STAG funding levels of several million was possible, and that some portion of any increase would likely be designated for air toxics monitoring in schools. Bill stated that he had testified on behalf of NACAA before the House Subcommittee on Interior and the Environment on the President's Budget, requesting an increase of \$50 million for states and localities. He noted that the Chair of the Subcommittee, Representative Norm Dicks (D-WA), voiced interest in hearing from NACAA members about their funding needs.

With regard to FY 2011, the Program Funding Committee discussed its recommendation for an increase of \$100 million over FY 2010 levels, particular how to best characterize the need for increased funding, which is necessary both to make up the shortfall from the past and meet new and emerging needs like climate change. Dennis McLaren (Seattle, WA) said that it was important to focus not only on the national benefits of increased funding, but the local benefits as well. NACAA Members were reminded to write to Congressional Appropriations Subcommittee Members supporting the association's request for increased FY 2010 funding.

Endorsement of Clean Air Act Advisory Committee vision and Goals Principles

Bill Becker reviewed the six guiding principles developed by the Clean Air Act Advisory Committee as part of a report on the vision and guiding principles for the national air program. The six principles include:

- 1. Establish clear goals and manage for results and accountability.
- 2. Use appropriate tools including innovative approaches.

- 3. Conduct sound research and use information effectively.
- 4. Build capacity among government partners for effective implementation.
- 5. Build a better and broader partnership.
- 6. Educate and involve the public.

The Board voted unanimously to endorse these six guiding principles.

Update on Air Toxics Monitoring Near Schools

Dick Valentinetti (VT) updated the Board and Chairs on EPA's effort to deploy monitors for air toxics at schools. Dick noted that \$2.5 million of STAG grants that would otherwise have been allocated to community-scale air toxics monitoring had been appropriated by EPA for monitoring air toxics at schools. With this money, EPA plans to monitor 62 schools for 60 days, relying largely on states and localities to deploy the monitors and collect the samples, according to Dick. The funding could better be used for 10 community-scale grants of \$250,000 each, Dick noted. Bill Becker said that NACAA will meet with EPA to determine "next steps" following completion of the school monitoring and data gathering. At that point, Bill noted that NACAA plans to encourage EPA to redirect this effort so that needed regulatory actions are undertaken – such as eliminating lead in aviation fuel and benzene from vehicle fuel – rather than merely increasing the numbers of monitors.

Presentation of NACAA Financial Statements

Bill Becker presented and explained the NACAA financial statements, including those covering the association's non-federal funds and the operating grant (through March 30, 2009).

Update on Future NACAA Meeting Locations

Bill Becker apprised the group of the arrangements under way for the 2009 Fall Membership Meeting, which will take place in Boston, Massachusetts. The Summer Board and Committee Chairs Meeting will be held in San Francisco, California. In addition, the 2010 Spring Membership Meeting will be held in Sacramento, California, and the 2010 Fall Membership Meeting will be held in Washington, DC, to commemorate the 30th anniversary of the establishment of a NACAA national headquarters.
