EPA-OAR provided additional funds to states in FY2016 using balances. EPA is encouraged to do the same in FY2021 and provide those additional funds to the regions with the highest need. If EPA wishes to change the formula, it should submit a proposal in its FY2022 budget justification for the Committee's consideration. |   | "[I]f EPA is proposing to change State allocation formulas for the distribution of appropriated funds, then EPA should include such proposals in the congressional justification." | "The Agency is directed to allocate funds for this program using the same formula as fiscal year 2015. House-Senate Omnibus Riders for FY 2022

- prohibition of funds for rules that require Title V permits for carbon dioxide, nitrous oxide, water vapor, or methane emissions.
- prohibition on EPA using funds to implement any rule provision requiring mandatory reporting of greenhouse gas emissions from manure management systems.
