House-Senate Final Bill Riders for FY 2024

- prohibition of funds for rules that require Title V permits for carbon dioxide, nitrous oxide, water vapor, or methane emissions.
- prohibition on EPA using funds to implement any rule provision requiring mandatory reporting of greenhouse gas emissions from manure management systems

House Riders for FY 2024

- Prohibits EPA from imposing mandatory reporting of greenhouse gas emissions from manure management systems.
- Prohibits EPA from implementing permitting requirements for livestock emissions under the Clean Air Act.
- Blocks the following regulations (issuance, implementation and/or enforcement)
  - The Mercury and Air Toxics Standards (MATS) rule;

- Regulations on light, medium, and heavy-duty vehicles;
- Ethylene Oxide regulations until the Food and Drug Administration (FDA) certifies that such regulations will not adversely impact the availability of sterile medical products;
- EPA's "Clean Power Plan 2.0."
- Directs EPA to update Congress on implementation of the GAO report "Renewable Fuel Standard: Actions Needed to Improve Decision-Making in the Small Refinery Exemption Program"
- EPA must brief the Committee w/in 90 days on how it can improve wildfire smoke monitoring and standards and other actions
- EPA must brief the Committee w/in 90 days on the eligibility of class 8 trucks to participate in programs to reduce emissions (including exclusions from participation)
- Rescinds funds for the Greenhouse Gas Reduction Fund
- Rescinds funds for the for environmental and climate justice grants.
- Prohibits funds to consider or incorporate the Social Cost of Carbon.
- Prohibits funds to approve the CA waiver for "Small Off-Road Engine Regulations: Transition to Zero Emissions".
- Prohibits funds for the "Federal 'Good Neighbor Plan' for the 2015 Ozone National Ambient Air Quality Standards"
- Prohibits funding for the executive order relating to advancing racial equity and support for underserved communities
- Discourages EPA from moving forward with eRIN program in the Renewable Fuel Standard
- Encourages EPA to identify and consider that federal, state and local activities, including prescribed burns on federal forestland, impact a local air district's compliance with air quality standards.
- Urges EPA to not issue final "Standards of Performance for New, Reconstructed, and Modified Sources and Emissions Guidelines for Existing Sources: Oil and Natural Gas Sector Climate Review" until certain concerns are resolved.
- Urges EPA to finalize the rule removing the 1 psi RVP waiver for summer gasoline-ethanol blended fuels containing 10 percent ethanol and to respond to future petitions in a more timely manner.

## Senate Riders for FY 2024

- Prohibits EPA from imposing mandatory reporting of greenhouse gas emissions from manure management systems.
- Prohibits EPA from implementing permitting requirements for livestock emissions under the Clean Air Act.
- EPA must finalize finalize its proposed Renewable Fuel Standard credits from renewable electricity (eRINS) within 90 days.
- EPA must provide a briefing on its hiring activity for the program and recommendations for improving the petition and approval process within 90 days.
