SUBJECT: Guidance on the Preparation of Exceptional Events Demonstrations for Wildfire

Events that May Influence Ozone Concentrations

The purpose of this memorandum is to distribute a non-binding guidance document titled, "Guidance on the Preparation of Exceptional Events Demonstrations for Wildfire Events that May Influence Ozone Concentrations."

The EPA Headquarters and EPA Regional offices collaborated in the development of this guidance to assist air agencies preparing exceptional events demonstrations for wildfire influences on ozone concentrations that meet the requirements of Clean Air Act section 319(b) and the Exceptional Events Rule signed on September 16, 2016, and posted on the EPA's Web site at https://www.epa.gov/air-quality-analysis/reatment-data-influenced-exceptional-events. This guidance document provides three different tiers of analyses that apply to the "clear causal relationship" criterion within an air agency's exceptional events demonstration. This document reflects input received from interested parties during the public comment period that closed on February 3, 2016.






# **Conceptual Model**


### **Pre-Wildfire Season**

  - ARA Reports, Media Articles, etc.












