




## Arctic ice cap is shrinking









## Naysayer claims have collapsed

- Ocean heat accumulation confirms that earth is absorbing more heat than it emits due to excess CO2 & other gases
  - J. Hansen et al., Science 308, 1431; published online 28 April 2005
- Corrected satellite record matches ground-based temperature record
  - C.A. Mears and F.J. Wentz, Science; published online 11 August 2005
- "Hockey-stick" shape of 1000 year temperature reconstruction confirmed by independent scientists

## Industry leaders joining consensus

John Rowe, CEO of Exelon Corp.: "We accept that the science on global warming is overwhelming." And: "There should be mandatory carbon constraints." -- Business Week

American Electric Power, the nation's largest power company: "Enough is known about the science and environmental impacts of climate change for us to take actions to address its consequences." -- American Electric Power

Susan Tomasky, AEP CFO: "We don't expect Kyoto timeframes to be enforced in the United States but we do expect the international consensus on this issue will prevail in the United States."

Wayne Brunetti, CEO of Xcel Energy: "Give us a date, tell us how much we need to cut, give us the flexibility to meet the goals, and we'll get it done." -- Business Week



## Consensus is spreading

Paul Anderson, Duke Energy CEO: "We have great faith in American innovation... Set the right goals, and Americans can — and will — lead the way... I'm troubled that our international competitors — motivated by mandatory emissions reductions — have gotten a head start." -- Charlotte Business Journal's 10th Annual Power Breakfast, April 2005

Jeffrey Immelt, GE CEO: "I know that protecting our environment and building our economy go hand in hand. And I know that green is green." -- Speech launching Ecomagination, May 2005

World Economic Forum (including CEOs/Presidents of Ford, Cinergy, Rio Tinto and BP): "Because of the cumulative nature and long residence time of greenhouse gases in the atmosphere, action must be initiated now... With properly designed programs and incentives, we can unleash the power of the market to accelerate the deployment of low carbon technologies, engaging both producers and consumers alike." -- WEF, June 2005



#### California clean car standards

Requires 29% reduction in global warming pollution per mile by 2016

Technologies pay for themselves in <5 years

### Partnerships with states

#### Power plant litigation

 Federal common law case to limit CO<sub>2</sub> emissions of top five companies (on appeal)

#### Vehicle advocacy and litigation

- Helping defend California's vehicle standards against auto company litigation
- Working for adoption in other states

## Holding industry accountable

#### Blocking new conventional coal plants

- >100 new coal plants on drawing boards
- Broad national coalition forming to oppose conventional coal plants
- Meeting energy needs with efficiency, renewables, and cleaner coal (IGCC with carbon capture and storage)








#### CO<sub>2</sub> concentration




Global Emissions




#### Slow start means crash finish

## Signs of change in Washington

#### Senate majority supports mandatory limits

SENSE OF THE SENATE.—It is the sense of the Senate that Congress should enact a comprehensive and effective national program of mandatory, market-based limits and incentives on emissions of greenhouse gases that slow, stop, and reverse the growth of such emissions at a rate and in a manner that—

- will not significantly harm the United States economy; and
- (2) will encourage comparable action by other nations that are major trading partners and key contributors to global emissions.

Passed 53-46, June 21, 2005.
